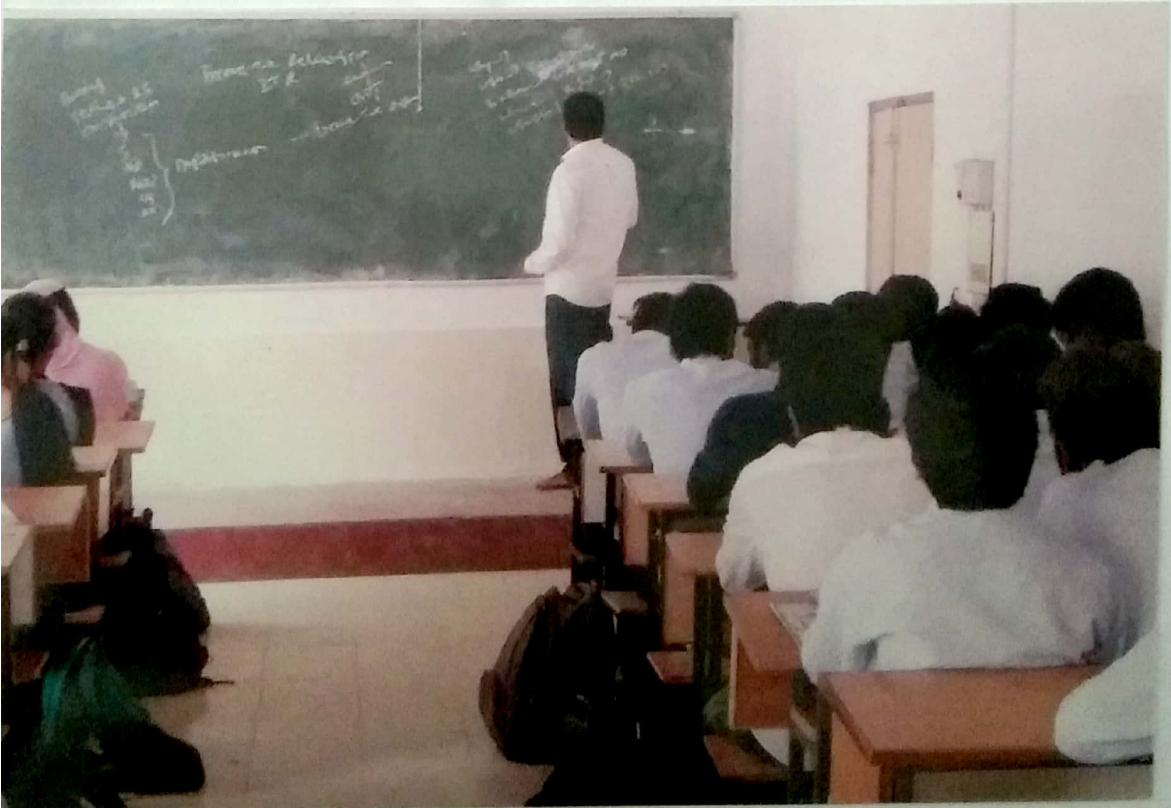

Income does not only mean money earned in the form of salary. It also includes income from house property, profits from business, gains from profession (such as bonus), capital gains income, and 'income from other sources'.

Incomes earned by you during the year are divided into five heads under the I-Tax Act. ... Income for salary include wages, pension, annuity, **gratuity**, fees, commission, profits, leave encashment, annual accretion and transferred balance in recognized Provident Fund (PF) and contribution to employees pension account. What is income tax and its types?

There are two types of taxes namely, **direct taxes and indirect taxes**. The implementation of both the taxes differs. You pay some of them directly, like the cringed income tax, corporate tax, and wealth tax etc while you pay some of the taxes indirectly, like sales tax, service tax, and value added tax etc. You continue avoid paying your tax bill, the unpaid amount could come out of future tax refunds if you're owed any. ... The lien could later become a levy, which means the IRS will seize your property to pay your bill. As with failure to file taxes, you can also go to jail for failure to pay taxes. 


